COMMUNIQUE First Quarter 2022

The first quarter of 2022 came and is already something of the past.

The world looked forward to 2022 as the year in which the burden from Covid-19 is going to ease and economies can be opened again and allowed to grow. Unknown to us was the beginning of a war in the east of Europe, and the implications it would have on global economies, already under much pressure.

In 2022 HQA will be reporting on health quality for the 18th year consecutively. Preparations are underway to request data from participating medical schemes for the 2022 annual reports. During the first quarter of 2022 the CAB continued its annual review process of the health quality indicators and data specs will be aligned accordingly. HQA will continue to enhance the value of its analysis and reporting to participating funders through enriching the dataset, standardising definitions and coding, reviewing and improving the quality metrics and a user-friendly reporting system aimed at optimising the value of participation.

A working group consisting of representatives from private hospitals and members of the HQA CAB was formed with the aim to standardise definitions used for measuring, for example admissions and length of stays.

A meeting will be convened in the second quarter of 2022 with health actuaries and data/coding specialists in order to review the technical methodologies applied by HQA. The purpose of the meeting will be to improve on transparency and standardisation. Nominees for attending this meeting are invited.

A working group for developing a registry for prostate cancer is in the process of being developed. A questionnaire is being circulated amongst urologists to assess an interest and willingness to participate.
